A more comprehensive list of tasks to which web development commonly refers, may include web engineering, web design, web content development, client liaison, client-side / server-side scripting, web server and network security configuration, and e-commerce development. 



Web Innovation PH is creating a decentralized payment ecosystem processing on the Ethereum blockchain leveraging smart contract technology.

How the Ethereum blockchain works on WEBN E-commerce:



- 1. Transaction Address Every successful payment has a unique TXHASH that can use to trace the transaction for verification.
- 2. Payment Receipt Where you can verify your payment if it is a successful or not.
- 3. Payment Claim Every purchase on the web development of product, the transaction will be saved on the blockchain Date and Time will be published and viewable on the etherscan for confirmation. Transaction data histories are recorded. This historical transaction data can help to verify the authenticity of assets and prevent fraud.
- 4. Buyer and Seller Ethereum address You can verify your payment where it goes by checking at the etherscan.
- 5. Exact Amount For confirmation of your payment amount will be displayed on the etherscan.
- **6. Increase efficiency and speed** Automating process with blockchain transactions can be completed faster and efficiently.

Cryptocurrency Payments

Enables selected cryptocurrencies to be used in the platform for payment. This strategy will help the general public to become more educated and aware on the uses and understanding on the digital currency process. Sellers will be able to accept major cryptocurrencies and utilize - especially the WEBN tokens in exchange with them with traditional (fiat) currencies. Buyers and Sellers will participate in a global decentralized commerce environment with a greater sense of security and total trust.



Using cryptocurrencies as a payment method in our platform offers the following benefits:

- **1. Fraud** Individuals cryptocurrencies are digital and cannot be counterfeited or reversed arbitrarily by the sender, as with credit card charge-backs.
- 2. Immediate Settlement No Intermediary and 3rd party (Instant Payment)
- 3. Lower Fees There aren't usually transaction fees for cryptocurrency exchanes because the miners are compensated by the network (Side note: This is the case for now). Even though there's no bitcoin/cryptocurrency transaction fee, many expect that most users will engage a third-party services, such as Coinbase, creating and maintaining their bitcoin walets. These services act lke Paypal does for cash or credit card users, providing the online exchange system or bitcoin and as such, they're likely to charge fees. It's interesting to note that Paypal does not accept of transfer bitcoins.
- 4. Identity Theft When you give your credit card to a merchant, you give him or her access to your full credit line, even if the transaction is for a small amount. Credit card operate on a "pull" basis, where the store initiates the payment and pulls the designated amount from your account. Cryptocurrency use a "push" mechanism that allows the cryptocurrency holder to send exactly what he or she wants to the merchant or recipient with no further information.
- **5. Access to Everyone** There are approximately 2.2 billion individuals with access to the Internet or Mobile phones who don't currently have access to traditional exchange, these people are primed for the Cryptocurrency market. Kenya's M-PESA system, a mobile phone-based money transfer and microfinancing service recently announced a bitcoin device, with one in three Kenyans now owning a bitcoin wallet.

Native Cryptocurrency Token

Buy-Back-Burn Program

The solution that support or stabilizing WEBN token price in the crypto-exchange to reduce the total supply and increase the demand of WEBN token.

The Buyback and Burn Program explanation:

A **Buyback** happens when a company spends a portion of its own profits to buy its token back from its token holders. This strategy aims at driving the price of the token up and/or stabilizing the price during downturns.

A **Buyback** and **Burn** happens when a company not only buys its tokens back, but it hen removes those tokens from circulation effectively "burning" them. This means that the same market cap is continually divided among the shrinking supply of tokens in circulation theoretically driving the price of each token up higher and higher over time.

How does it work?

- 1. 30% of the total profits generated in the platforms annually will be used to re-purchase WEBN tokens.
- 2. WEBN token buybacks will be made annually, it means the buyback and burn will happen 3x a year until we reach the total supply of 1.B WEBN tokens.
- 3. All WEBN token buybacks will be performed on open markets.
- **4.** WEBN tokens will be repurchased at a price that does not exceed a 50% premium of the highest independent bid or the last quoted trans action price.
- 5. All the purchased tokens will be shared as follows:
 - 40% to be burnt and removed from the total supply
 - 50% for staking rewards
 - 10% reserved for WEBN mobile game points
- 6. WEBN token purchases i.e. total number of tokens purchased and burned can be seen at the burn address on etherscan.

Tradable to Crypto Exchange

As part of the WEBN token trading strategy of Buy-back-burn mechanism, WEBN token will be listed at medium and large volume crypto-exchanges.


