1. Introduction

The recruitment of international students is an irreversible trend. As the school-age population is decreasing, the number of university students is gradually decreasing and financial difficulties due to the tuition freezing require a new breakthrough for universities. Meanwhile, more and more international students are considering going to Korea to study under the influence of the Korean Wave.

International students are regarded as the best human capital resources for attracting talents because they have diverse economic, political and social/cultural advantages. The effect of promoting consumption and improving the educational balance caused by international students during their stay can be seen. After graduation, they can expect positive effects in the labor market as excellent talent by using their own language and experience. In terms of politics and diplomacy, the advantage is that they can build friendly networks to connect people and share cultural experience.

Under this background, the Ministry of Education has set its goal of attracting 200,000 international students by 2023 and universities are working to strengthen the campus's global capabilities. In fact, the number of international students has increased from about 84,000 to 142,000 over the past five years. In the case of following this trend, there will be more than 300,000 international students planning to study in Korea by 2023, exceeding the Ministry of Education's target.

Unlike the importance of international students and development of relevant markets, there is major progress in the recruitment and management method of international students. Unregulated intermediaries are making unfair profits between universities and international students, administrative management using paper documents and international students rely on formal stay support instead of self-sustaining. It reduces the satisfaction of studying abroad in Korea and the brand as a country to attract international students. As a result, It overshadows the aforementioned positive and will only produce churn/illegal issues.



DoDream Chain makes the best way for international students to study in Korea. DoDream Chain improves the procedure so that international students can design their own study abroad plan and allows them to choose qualified intermediaries as needed. Blockchain can be used to replace the delivery of paper documents and to verify the integrity of the uploaded original. In addition, it can contribute to the increase of satisfaction of studying abroad by providing a space for users to voluntarily share information and learn language.

In order to realize it, Dain Leaders with 10 years of experience in integrating the university student career management system and solution, will be a key partner of the DoDream Chain. Dain Leaders has been recognized for its expertise in securing management system services about 50 major customer universities and 600,000 system users. It registered 15 patents and copyrights and it established its position by carrying out blockchain government R & D last year.

Dain Leaders has developed and launched DoDream Chain's first service 'Study Abroad Platform dodream' and contributes to the establishment of the DoDream Chain ecosystem. Furthermore, Dain Leaders is working to increase the number of users and of partners participating in the DoDream Chain. The goal is to increase the efficiency of recruiting international students and develop the ecosystem so that participants can enjoy the equal benefits.

2. Problem Recognition

2.1 Unregulated Intermediary

International students preparing to study in Korea search for local intermediaries first. It is to obtain necessary information and identify documents to submit. However, because of asymmetric information and dependent relationships are formed, students can not assess which broker is reliable. As a result, they will be designed to enter the university in a direction that maximizes the interests of intermediaries rather than meeting the conditions they want.

High fees and costs incurred in this process are transferred to



others/organizations. This increases the burden on students and decreases reduces the satisfaction of studying abroad. According to the university's alert announcement data, the number of international students who dropped out of the 'university' was 2,753 in 2016, 3,593 in 2017 and 4,742 in 2018. The number of students who are dropping out is increasing rapidly every year. It is difficult to manage the drop-out situation and of course they become illegal immigrants.

As such, an unregulated intermediary has gone astray. Due to the non-transparent working structure, it is inadequate and ineffective and as a result, it leads to a decline in the reputation of the university and the national brand.

2.2 Forgery of Certificates

Because of fake documents, there is a hole laxity in the immigration management and financial capture of foreigners. A process is required to prove and confirm your qualifications, but there is a possibility of fraud. In fact, there are frequent cases with an intermediary disguised as studying abroad for the purpose of illegal employment and attempting to study abroad by forging insufficient qualifications. There is an attempt to solve through strengthening regulations, but there is a clear limitation, such as checking the documents with eyes rather than technical methods at the stage of reviewing them.

2.3 Absence of Community

When we travel abroad or stay overseas, we get the necessary information through acquaintances or Internet communities. Although it can be helped by locals or the national institutions, we prefers more familiar and accessible information. Information that is spontaneously generated and shared among the resident community, will bring a very satisfactory experience abroad.

On the other hand, international students studying in Korea are hard to acquire information for their lives. This is because there is no platform for the international student network and absence of the platform capability of the information sharing which is selected and verified. There are not much



sources for international students to find, from help for language study, housing, finance, medical care and cultural differences. The dissatisfaction of international students is due to the lack of such information.

Interchange between local and international students is also not smooth. A person of Uzbek nationality who is studying in Korea for two years, receives two questions a week. Because acquaintances of their home country ask questions about studying in Korea. Even if Mr. A explained it for a long time, the parties could not get enough information. The inconvenience of both sides is due to the absence of the community.

2.4 Fragmented Management of International Student Document


There are many types of documents to be managed by international students, but they are scattered in various places (organizations) and cause inconvenience. International students should have documents such as graduation certificates, report cards, certificates of enrollment, foreign registration certificates, certificates of license and permissions whenever information on leave jobs, residence changes and employment are changed. Students must visit the agency or sites to apply for documents. The cost of inefficiency in this process is estimated at about 7.35 billion won.

Furthermore, there is no system to systematically manage the personal history of international students. According to the National Institute of International Education, a member of the Ministry of Education, "International Students Settlement Support 2018 for Life in Korea," more than 50% of students said they would stay in Korea after completing their study. It is the main purpose to get a job in Korea or take a higher education. At this time, the absence of the verification system to history background of international students that can refer to each institution, makes it difficult to accurately evaluate the workforce. As a result, it leads to asymmetry of information and inefficiency and economic loss.

3. Market Analysis



Reducing the birth rate brings a lot of changes to the industrial outlook. Especially, the education sector will be affected first by the decline in school-age population and the university is under the same influence. The number of students who went to university in 2017 was 390,000, compared to 470,000 in 2011, a decrease of about 20% in six years. This is not the end. Given the sharp decline in the total fertility rate over the past 20 years, the number of university students will also decline rapidly in the future. This change causes the university to reduce the enrollment quota and fall into financial crisis.




On the other hand, the number of international students who want to study in Korea is increasing due to the influence of the Korean Wave. This is in line with the demand of universities to strengthen their internationalization capabilities and secure recruiting personnel exceeding the designated number. In 2015, the Ministry of Education announced a plan to recruit 200,000 international students by 2023, contributing to this trend. In fact, the number of international students is increasing steeply. It has an annual growth rate of 20%, with 100,000 in 2016, 120,000 in 2017 and 140,000 in 2018. The economic effect of introducing international students is estimated at about 700 billion won in 2018.

The related market is composed of tuition, Korean language education,



housing and international student recruitment except for consumption that international students generate during their stay and other economic effects. Each market is in the stage of development with the size of international students, the size of the market to be processed on the online platform is estimated in proportion to the number of international students and as follows. The amount of tuition (language training) is 42 billion won, tuition (degree course) is 129 billion won, Korean language education (TOPIK) is 6 billion won, housing at an affordable price is 800 million won and suitable employment is 500 million won. It has a total of 170 billion won.



The percentage of international students from major countries is as follows. In 2014, more than half of the students were from China, in 2018, the proportion of students from Vietnam and Mongolia increased, improving the diversity of international students. The number of students from Vietnam is expected to increase in the future thanks to the increase in Korean companies' entry into Vietnam and the Korean Wave craze including football coach Park Hang-Seo.



4. DoDream Chain

DoDream Chain is a blockchain network centered on international students. It is possible to improve the experience from the preparation stage of international students to the moment of settling in Korea and to enhance the academic achievement through sharing transparent and proven information. The dropout rate of international students recruited based on trust will be low and as a result, the brand image of related organizations can be improved and management efficiency may be improved.

DRM token and smart contract motivate each participant to share information and improve reliability. DRM tokens provide economic incentives to initial users to share the benefits of platform growth. In the long term, the virtuous cycle structure is created by increasing users and information accumulation, which causes the demand of each participant.

4.1 Participants

4.1.1 International Student

International students are the key users of DoDream Platform and DoDream Platform is an A to Z platform of studying abroad to international students. International students can do the following activities. 1) When preparing for studying abroad in the local area, user can design the study. They can enter the study abroad course, region, major, tuition fee and admission time directly and find the study abroad course without limit of information. 2) It is possible to connect in the community, covering the state of students preparing study, international students and graduates. By sharing the necessary advice for study and useful information for the stay in Korea, they can get material and psychological help. 3) By managing all the documents and history related to academics and the right to view information by themselves, they can motivate growth and access to more opportunities.

All activities of international students help the growth of the platform and a series of activities should be compensated. As participants, international students can be rewarded in the form of points or tokens and compensation can be used for the learning service provided by the



platform, support for studying abroad applications and pay fees. This can help students to study and stay, also reduce the economic burden.

4.1.2 Study Abroad Agency

The study abroad agency is an organization that consults international students and helps prepare for studying abroad. Both international students and Korean universities should maintain a good reputation and it becomes competitive soon. Students' grades, moderate departure rate and illegal stay rate who went abroad through the study abroad agency are important indicators for studying abroad and universities.

The study abroad agency can unify administrative work related to the application for admission by using DoDream and can ensure the integrity of the details. The agencies who have selected the proven international students and have accumulated trust for a long time will become a key partner and It can be classified from the broker/intermediary aiming only for the purpose of maximizing short-term profits. Furthermore, it can be promoted to local students who are considering studying abroad.

4.1.3 University

The Ministry of Education implements the International Education Quality Assurance System (IEQAS: International Education Quality Assurance System) to select and certify universities qualified for internationalization capacity. The university that has received the certification can simplify visa issuance by the standard admission permits for international students who want to go to school and get publicity benefits such as participating in overseas Korean study fair and media reports. And it is a powerful motivation to select international students autonomously without being limited to the quota number of students.

In order to receive IEQAS, it is necessary to meet the essential indicators and core conditions. The essential indicators consist of items that confirm the international student's stay rate. The proportion of students staying illegally should be less than 2 to 4% or the dropout rate should be managed to be less than 6%. The core condition indicator consists of the burden of tuition fees, the health insurance rate, the language ability (Korean/English) and the ratio of new students' dormitory and the number of items assigned by educational institution must be met as prescribed.



These standards make university's efforts to recruit, select and attract students to stay in the university. The university can create channels to communicate directly with local agencies and share their work through DoDream Chain and by looking into the reputation of the study abroad agency the verification of the international students supported and the reliability can be managed in advance. Furthermore, using the dropping out prediction program that analyzes and provides data of DoDream Chain, the residence and academic achievement of the international students can be managed systematically.

4.1.4 Employer

The employment of international students varies according to the period of stay and the visa issued. Students who have received a study abroad (D-2) visa or short-term language training (D-4) visa can get a part-time job (part-time job) within 20 hours after six months since entering the country with permission from the person in charge. Students who have been licensed can work in the range of interpreters, translations, restaurant assistants and general office assistants. The international students who are about to graduate can work all day by changing to employment visa $(E-1\sim E-7)$ or job-seeking qualification visa (D-10).

Depending on the nature of the business, there are employers who want to hire international students. They are, as in the case of Koreans, employers need certificates to verify the employee's credentials and employers want to make sure employee have a legitimate qualification. Employers can check the history of international students collected and verified at DoDream Chain and if necessary, can post application announcements and receive more applications from international students.

There is a high demand to recruit international students in the community. The areas other than the metropolitan are developing at the same time as population decline and aging and labor shortage is getting smaller and smaller. To supplement this, local governments and employers are actively turning to link with local universities.

This industrial structure, the change of the laborable population by region, creates a virtuous cycle structure that international student who wants to




manages their portfolio and store the information in a transparent manner and employers can find abundant and reliable applicants at DoDream Chain.

4.2 DRM Token

DRM token is a value transmission means used in DoDream Chain and is a basic unit that works by a smart contract. DRM token was created on the decentralized blockchain platform and the owner of the token has full authority, so a third party can not be edit or delete arbitrarily.

4.2.1 Token Flowchart



DRM token can be obtained by contributing to the growth of DoDream Chain ecosystem and receiving compensation and the user pays a tokens and can use the service or goods of the project when using DoDream Chain.


Activities such as sharing experiences, information registration, history verification and question-answering to help other participants acquire information are encouraged through rewards. Participants can use other services provided through DoDream Chain as a DRM token or sell them to buyers and pay them. In the case of international students, DRM tokens can be used to exchange values in situations such as used goods trading and academic data sharing under the agreement of both sides. Students of various nationalities will be able to conduct personal transactions without remittance or exchange fees.



If participants want to match between others, inquire user details and if they are promoting for a specific purpose, participants should pay DRM token. Participants can receive proven information and secure a transparent reputation of the party by providing the payment details of the token.


The more ecosystem and data of DoDream Chain are abundant, the more demand for DRM tokens can be generated to users of services and goods. Therefore, users and relevant parties who receive DRM tokens as compensation have the factors to voluntarily activate the ecosystem.

4.3 Workflow









The above workflow represents the storage and flow of data. Only the authorized user generates a node and that can prevent unknown objects from reading data based on a private blockchain. The mode in which data are stored in the blockchain is as follows. It creates an ordered block to the pre-order service and distributes it to all the peers on the channel. All peers check whether the incoming block meets the warranty policy and the order status. Finally, each peer updates the status of the order by attaching the block to the chain of the channel.

5. Service Introduction

The study abroad platform dodream.io (hereinafter dodream) is a representative service to which DoDream Chain will be applied. It aims at a platform focused on international students by separating from the structure centered on the study abroad agency and provides a better experience of studying abroad with open information and low commission.

DoDream is released sequentially in the order in which the ideas are applied. This is because it can save time and money by checking the user's responses and verifying the business hypothesis and it can build




more advanced types of service. Therefore, study abroad dodream is developed in two stages and the service has the following characteristics.

5.1 dodream Study Abroad Platform 1st Stage

The first stage of study abroad dodream focuses on customized services aimed to international students. First, it ensures awareness of the platform through increasing the number of users and creates publicity synergy for Korean universities and local study abroad agencies. It is currently a practical service and includes the following detailed services.

5.1.1 Dream Design




Dream Design is a personalized study abroad design. A total of 60 universities are informed and designed according to the conditions and circumstances of international students. By helping students preparing for studying abroad to collect fragmented information and check it easily and quickly, damage from unregulated intermediary can be prevented and commission costs can be reduced. And if the student needs it, it also guides the student to consult with a well-rated study abroad institution. Dream Design, which can design the study abroad course directly, plays a



plays a key role at the preparation stage.


5.1.2. Do Play



Do Play helps international students settle in the country by providing content that they can enjoy in Korea. It can be found from traditional culture such as Korean holiday, handbook to the latest trends such as photo point, local restaurant information, concert, etc. Information gained and shared from the perspective of foreigners may be more familiar to international students. In Do Play, Dream Maker, which consists of 13 international students, serves as an initial participant–students. They share daily tips that they have experienced in Korea, such as shopping and receiving courier service, and producing content related to Korea. As such, Do Play and Dream Maker serve as bridges between Korea and students who are concerned about studying abroad.



5.1.3 Do TOPIK




TOPIK is an abbreviation of 'Test of Proficiency in Korean', which means Korean language proficiency test and It is a test to measure and evaluate the ability of foreigners to use Korean. TOPIK consists of TOPIK I (Level 1~2) which is applied to beginners and TOPIK II (Level 3~6) which is targeted at intermediate and advanced. In general, international student must acquire TOPIK Level 3 to enter the university as a regular course, and they can graduate only after achieving TOPIK Level 4. In addition, TOPIK score plays a major role in getting scholarships, job hunting and visa re-granting, which is a major academic indicator for international students.

The TOPIK, which was first implemented in 1997, has been rapidly increasing in the available area and applicants. It was implemented in 156 regions in 40 countries in 2015, and expanded to 186 regions in 47 countries in 2018. The number of applicants is 200,000 in 2015, 250,000 in 2016, 290,000 in 2017, and 330,000 in 2018, which shows an annual growth rate of 20%. As the number of international students increases and the use of the test are enhanced in the future, the growth is expected to continue.



International students can study the TOPIK test online at Do TOPIK. They can learn more deeply through type of questions such as reading comprehension, matching the correct content, finding the main content and arranging correct order of sentences and they can quickly check expected score by solving random practical tests. It can be an effective learning tool for international students preparing to study in Korea, who have difficulty in accessing Korean textbooks and test sites and checking frequent scores due to cost issues. Do TOPIK enhances the possibility of studying in Korea and solves language problems to help international students to stay in Korea.

5.1.4 Do Talking



Do Talking is an SNS community where international students can upload short articles or photos in feed form. It is a space where you can build a network with students who have settled in Korea before, and seek answers to concerns and difficulties. If the number of users and upload increases, the feed will serve as an information board.

5.1.5 Step Point

Step Point are points gained by participating and taking activities of the DoDream Platform, motivating study in Korea and promoting a positive



exchange of information. According to the cumulative Step Point, users are divided into 'Junior', 'Rookie', 'Pro', and 'Master'. The higher the point gains, the more active activity is.

In the first stage of the DoDream, users can acquire points through membership, attendance, content posting, and event/advertisements. And when using customized study design and TOPIK practice test service, a certain amount of point are deducted. As the DoDream service expands, the process of acquiring and using Step Point becomes diverse, and it can be converted into DRM token through the wallet.

5.2 dodream Study Abroad Platform 2nd Stage

The second stage of study abroad dodream is to simplify the process from registration of documents to remittance of tuition fees and all expenses and management of international students after admission. First, it improves the procedure for students to proceed their own customized study abroad strategy, which can only be done through intermediary study abroad consultancy agency, they participate as partners that can provide O2O consulting services to ensure an online expanded customer base from offline local-based sales and on-demand services.

In the second stage of study abroad dodream, each participant of DoDream Chain can benefit from the service. The university can predict dropout and use pre-management services. It is possible to find out which students are more likely to drop out by checking the existing data and finding the factors affecting the dropout. Students who are represented as alert groups in the relevant factors can take the pre-management such as counseling and support, and at the entrance stage, they can block fake studying abroad. And by enhancing the functions provided in the first stage of study abroad with dodream, international students can get more utility. A typical example is the practice test for the TOPIK and the expansion of questions by type and difficulty level, and the provision of e-learning contents for conversation practice.

Finally, blockchain-based data management and function using wallet are applied. It is linked with MetaMask, an extension program of the web browser, to make direct transactions in the DoDream service and to



receive/pay DRM tokens. Blockchain-based data integrity verification and compensation mechanisms work well. However, if other wallets are considered more user-friendly and efficient, they can be further linked or replaced.


