



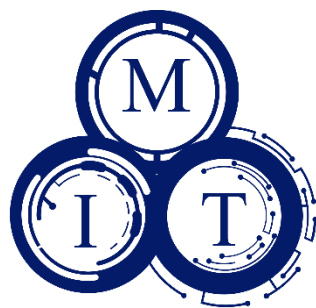

## Company overview

IMSMART Company is proud to launch its own cryptographic token. Although we know that the industry of cryptocurrency is already well populated and prevalent, this White Paper will provide enough information that can help you understand why we are issuing a token, what it will do, and how you can be part of the exciting quest for success and the growth of IMSMART COMPANY.

IMSMART Company Limited is the developer and issuer of the IMT Token, which was established in 2018 in Hong Kong under the partnership with Smart IoT Technology, which has an office in Bangkok Thailand and Singapore. The business partnership was established to facilitate the advanced development and deployment of SME 360 solutions.

Since the end of September 2017, Bitcoin was trading around US\$ 4,400 and cryptocurrencies had a total market capitalization of about US\$ 145 billion, during this time the cryptocurrency markets have experienced a full market cycle. We covered the industry's meteoric rise that saw Bitcoin's price near US\$ 20,000 and a total market capitalization that eclipsed US\$ 750 billion. It was reported on the dramatic shift in post-euphoric market valuations in 2018 that saw Bitcoin slashed to less than US\$ 3,200 and total market capitalization recede to around US\$ 110 billion. More recently in 2019, we've detailed the resurgence in market demand that saw Bitcoin rally past US\$ 13,000 and total market capitalization escalate back above US\$ 200 billion.

Imsmart Company and Smart IoT tech. founded this business partnership because we identified a strategic opportunity to provide technology services and harness the Blockchain technology as a tool to empower SMEs enhancing the payment system and liquidity. We realized the potential of combining IoT and Blockchain technology as this together can revolutionized and build a new process of business.

Imsmart company and Smart IoT Technology has a vision to empower SMEs particularly in Thailand we as partners would want to bridge the gap between traditional and digital business platforms, to empower SMEs with new generation electronic payments, Blockchain, and IoT technology solutions. ## IMSMART Token

IMSMART Token "IMSMART IMT" a cryptocurrency token under Ethereum Blockchain ERC20. IMT Token is a proof of work and proof of stake crypto token designed to be utilized in the product distribution market its goal is to provide the business from small to medium enterprises to gain access to the new era of payment and distribution.

We in IMSMART Company aims to display to the market the value of utility by providing to our community and collaborates IMT. Below is an illustration of our IMT Utility as a Token.





## Technology

IMSMART Company Limited is the developer and issuer of the IMT Token, a utility token that is exclusive to the SME 360 ecosystem. IMT Token is an Ethereum Request for Comment – 20 (ERC-20) token with a total token supply of 999,999,999 units. ERC-20 is a technical standard used for smart contracts on the Ethereum Blockchain to implement tokens.

IMT Token will enable IMSMART Company to expand and activate all parts of SME 360 ecosystem to achieve our goal in empowering Small and medium enterprise by implementing the whole platform in crafting new system of doing business.

We have chosen to launch IMT Token as an ERC-20-compliant utility token on the Ethereum Blockchain because it has been estimated that more than 200,000 ERC-20 tokens coexist on the Ethereum Blockchain and because they live on this Blockchain, they benefit from its technology. They are stored on Ethereum addresses and sent using Ethereum transactions. The ERC-20 token standard also contains the basic modalities of what a token should implement for it to start trading after launch. Such modalities include token transfer, balance inquiry for specified addresses and determination of total token supply.

As the most popular global standard for implementing smart contracts to develop tokens, ERC-20 defines a common list of rules for Ethereum tokens to follow within the broader of Ethereum network. This common list of rules includes the manner on exactly how tokens are transferred between addresses and in what way data are accessed.

These rules result in maximum predictability and reliability when deployed, and render possible interoperability with other Ethereum token standards. The use of ERC-20 makes tokenization less risky as all adhere to the same general standards. It also brings a kind of uniformity to the network, reduces the complexity of token interaction and enhances token liquidity.

As an ERC-20 token, IMT Token can be use in variety of ether wallet which can be use in common marketplaces without having to establish enhanced communications between the IIMSMART Team and developers of diverse marketplaces.





## Wallet

One of many reasons why Imsmart chose ERC-20 protocol to build IMT Token is because, most digital wallets that support the Ether cryptocurrency also supports ERC-20-compliant tokens, and this will maximize the custodial opportunities for IMT Token in utilizing existing digital wallet technologies.

IMT Token is listed to several mobile wallet applications and wallet exchanges. We have white listed our IMT Token to Eidoo wallet. We choose this wallet because this mobile app has a beautiful and user-friendly interface with an intuitive order book. We also white listed IMT Token to Trust wallet the official cryptocurrency wallet of Binance.

Eidoo wallet and trust wallet application are being utilized by our sme 360 community in making transactions sending IMT tokens to our iMTrade online vendors (Online Marketplace) in buying products and services, however some of our community members don't want to use Gas to pay for transaction fees, for this reason they created an account in imxchange.pro to transfer IMT, some of our community members prefers to use the iMXchange because it uses IMT as the payment for IMT transactions.

IMSMART Company launch an ERC-20-compliant token due to the industry's familiarity with the standard, and this correlate with our Reward wallet application which gives rewards to users who joins the reward program. Instead of holding their crypto or token assets, they can join the smart rewards and get up to 12 percent of returns from the amount they placed in their account. Another wallet which is underdevelopment is the IMPAY Wallet, this mobile wallet is a companion application of IMPAY MasterCard, IMPay will emphasize the utility of IMT Token as it can be utilized using the card as payment and POS using the mobile application .







## IMT Token a Utility Token

Blockchain technology is enabling the effective transfer of value across the internet; one of its characteristics is Tokenization. The fluidity and liquidity created by this concept helps to connect products and services while defying the restrictions of location and continually breaking the barriers of compatibility.

A class of token that is growing in popularity and proving to be very essential within the blockchain ecosystem are 'Utility Tokens'. These class of tokens primarily exist as accessibility elements on the blockchains that they represent. 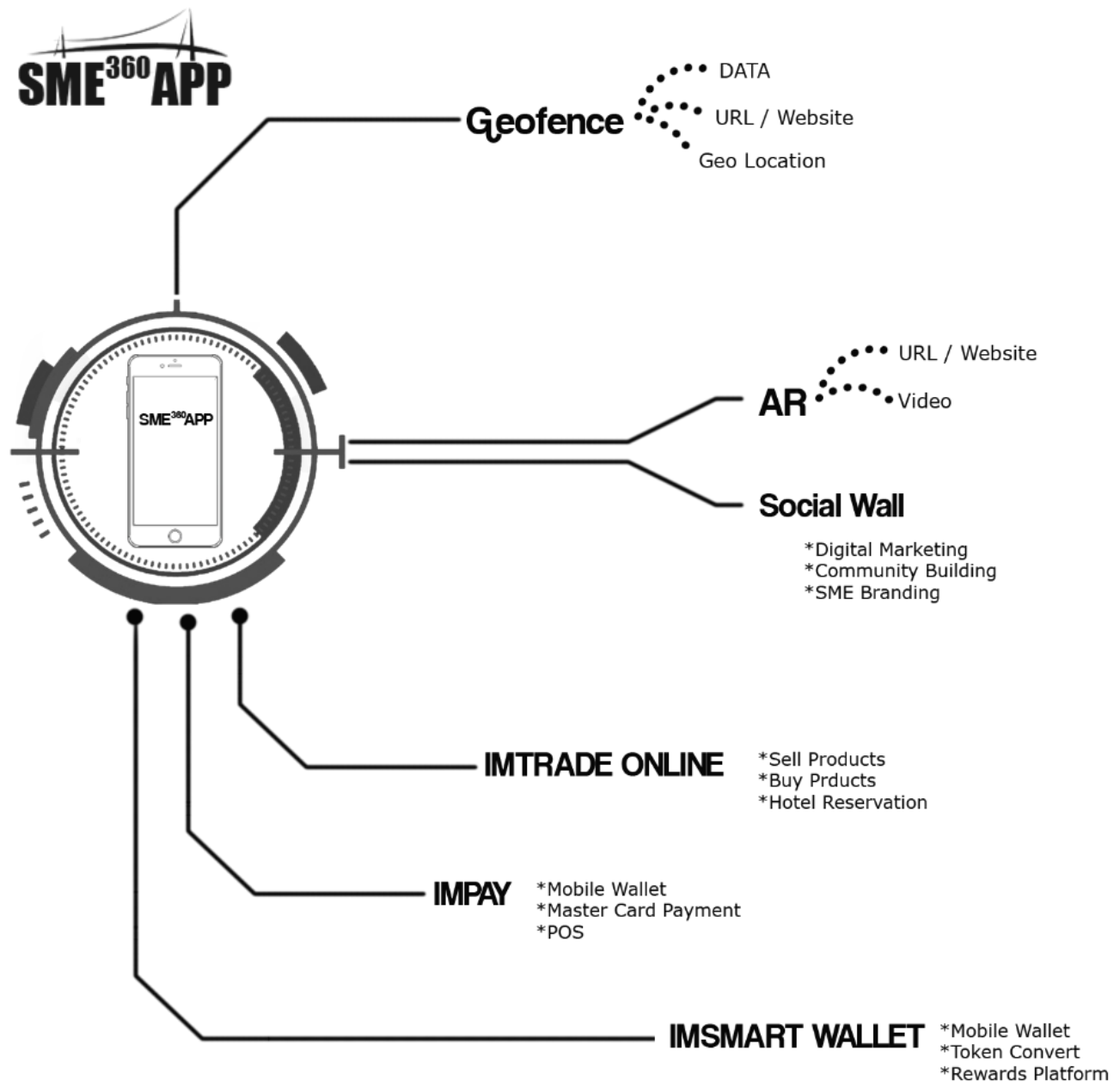




## SME 360 Mobile Application

SME 360 members will also have the power to utilize Augmented Reality and Geofencing technology; this will help our community level up their way of presenting and delivering messages.







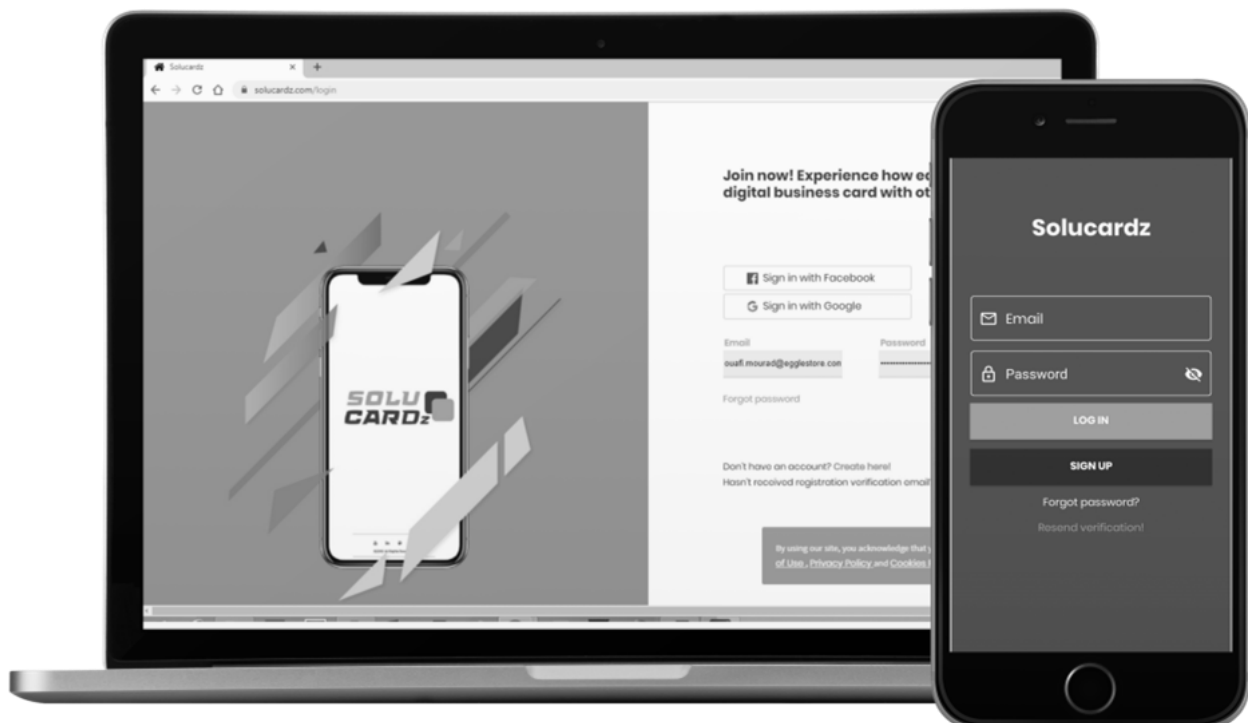
## DIGITAL BUSINESS SOLUCARDZ

IMTrade offers free services for SMEs to enhance their marketing strategies using new technology and the internet.

IMTrade aims to improve the business capabilities of all SMEs in Thailand by offering a platform of platforms, supporting B2B and B2C transactions. This will enable SMEs to connect to other business platforms and they will be able to connect to consumers and end-users.

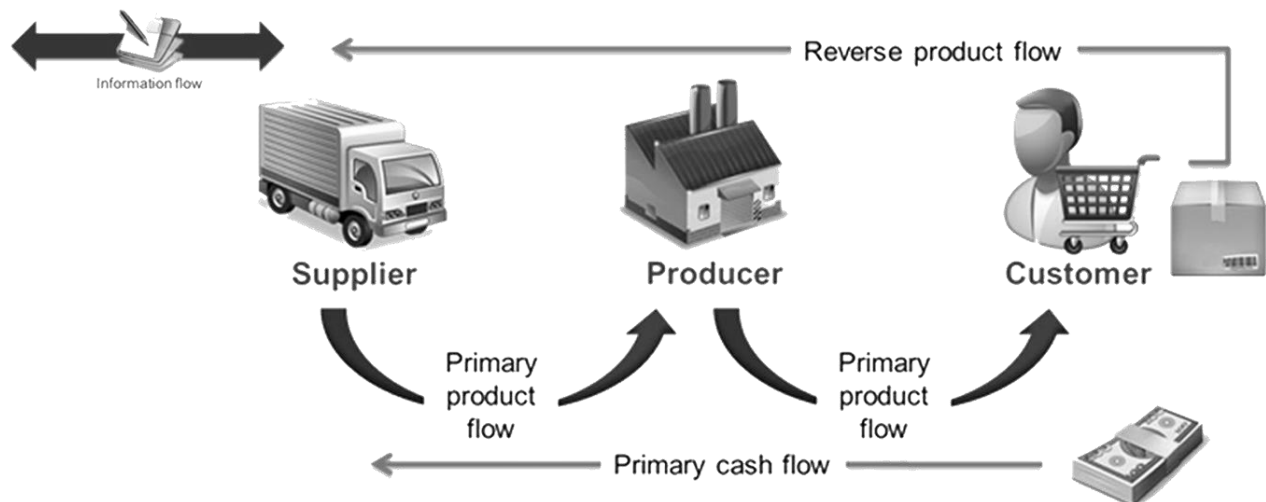
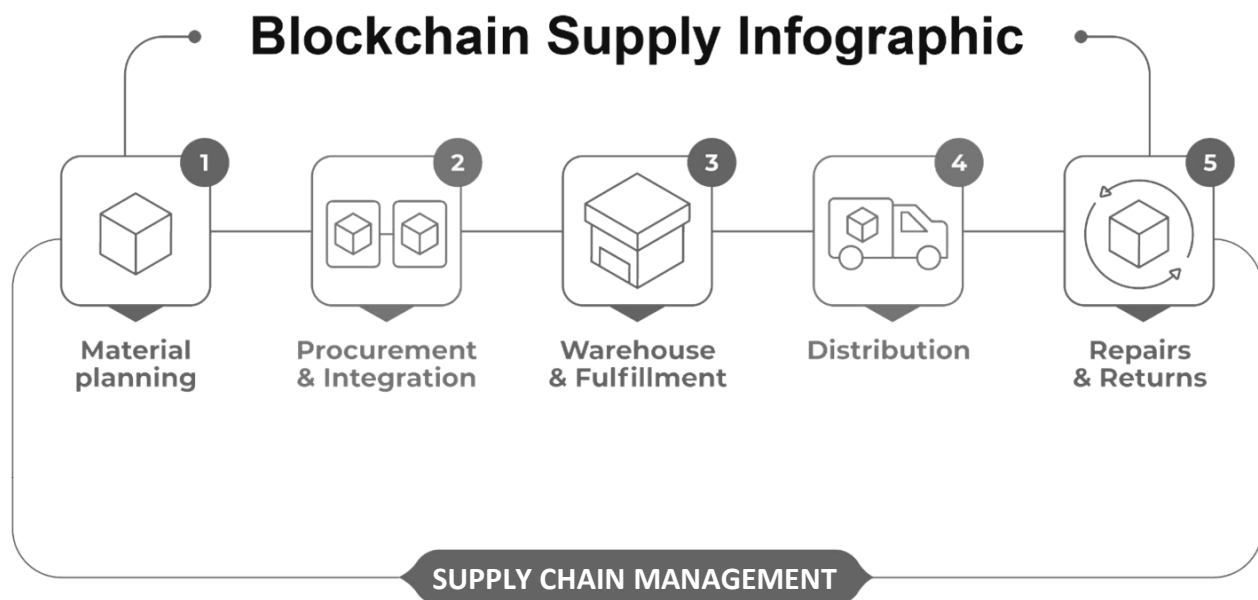




## Blockchain 360

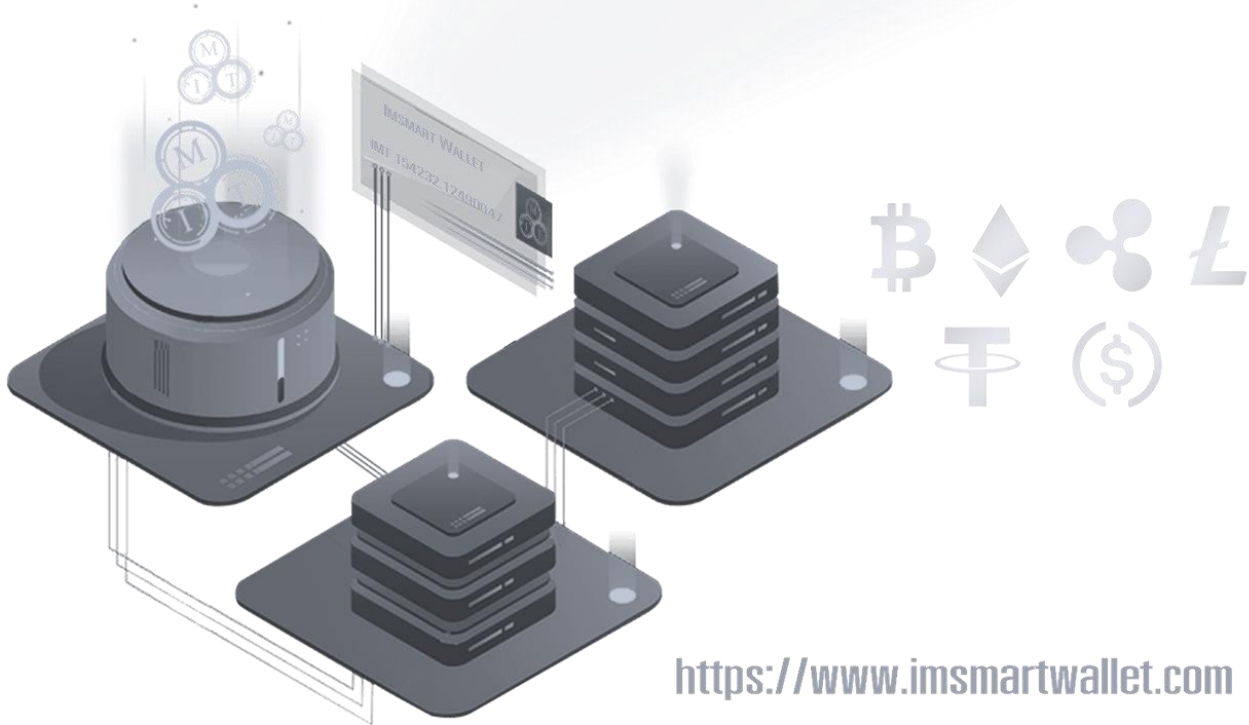
