in the physical space, and an online type of currency, a "Virtual coin" purchased for \$1 directly from within the game, was used to convey this value. Sales of these coins, arranged outside of the system on sites such as eBay, became prevalent, and still is to this day. That same phenomenon of digital asset scarcity and value

was introduced with the advent of Blizzard's immensely popular. An in-game auction house was created to buy and sell scarce items,

such as swords and armor, with in-game "Gold". Again, a huge aftermarket was created, with in-game items and "Gold" selling on eBay.



MARKET OF GAMING INDUSTRY

According to H2 Gambling Capital, global online gaming revenues were worth an estimated \$43 billion in 2017, making up 10% of all global gaming revenues (offline and online combined). H2 predicts that by 2022, the global online gaming market will be worth €65 billion. With over 6 million adult gaming around the world and estimates of greater than 10 million for 2020, the gaming market overall is growing rapidly, with the online segment of the market expected to accelerate faster than that of traditional casinos.

By 2017, mobile play accounted for an estimated 37% of online gaming revenues, over triple the 2010 mobile user base of 11.5%. H2 predicts that mobile use will continue to rise, reaching 49% by 2022. However, the major mobile platforms which dominate the market have heavily restricted "real-money" gaming apps from listing on their app stores or have banned them outright. Mobile adoption has been a significant barrier to growth as gaming operators stick to the old "native app" model, despite the leading app stores consistent and universal ban.

Despite continued growth, the online gaming industry faces a range of problems, for which La Devise Technologies offers a unique set of solutions.





PLATFORM STRUCTURE AND BASIC SERVICES

La Devise is a comprehensive ecosystem, consisting of mutually-referenced elements.

Unified Authentication. The functionality of a unified system of authentication (including social networks) enables users to easily connect to the platform and get access to all the opportunities offered by the service. Two-factor authentication and the possibility to instate IP blocking strengthen the capability of protecting user accounts.

Unified Billing and Dual-Currency Operations. A unified system for receiving payments via reliable payment servers provides for all the requirements of the platform. As blockchain is a relatively new technology and has not yet become massively used, dual currency operations are a crucial instrument for every game. Developers can receive payments for their games in usual fiat currency as well as in LDC COIN, the latter providing a range of advantages for all participants of the platform.

Customer Support Service. An around-the-clock, support service enables the reduction of natural user outflow. The deeper the support service is integrated into a game, the higher the loyalty of its players is. We already provide a bilingual, 24/7 user support service for Destiny. Games projects. If needed, the offering of languages will be expanded. We propose three levels of integration for projects: basic, advanced, and the complete package, whereby employees of the support service can answer questions regarding the particular project.


The public area is a unique page for the particular developer. It can be personalized to the level of a corporate site, consisting of news, announcements, competitions, voting, and messages.
