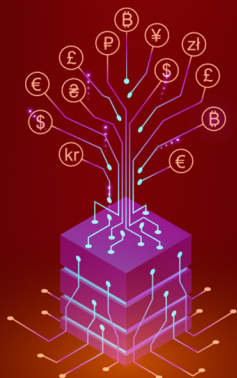

### 1. PROSPECTS OF FOREX MARKET

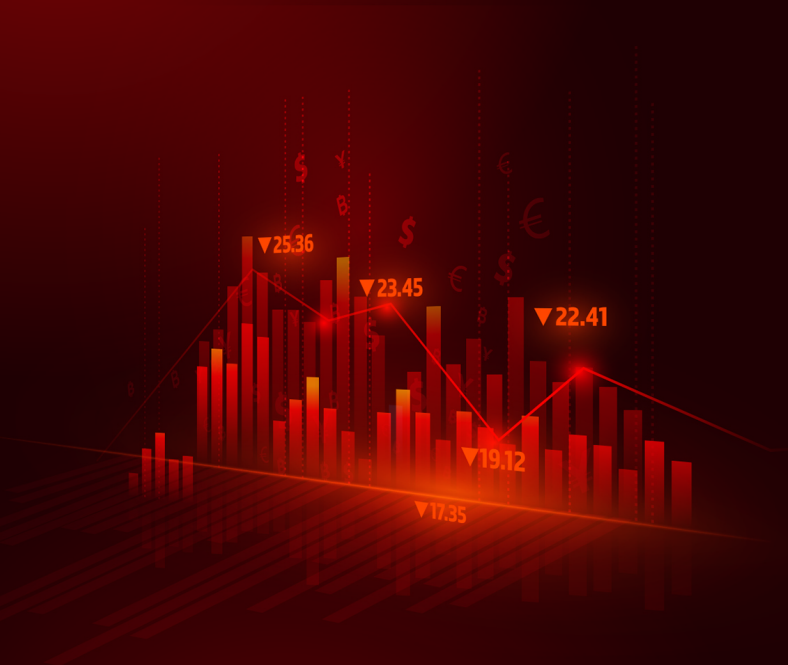
