Rise of the ICO

One of the most disruptive concepts to emerge from the rise of blockchain technology is the Initial Coin Offering, or ICO. The ICO gives cutting-edge blockchain startups from around the world an exciting new way to raise capital that crosses all borders and is open to anyone, regardless of wealth, connections, or banking status.

In 2013 Mastercoin held the very first ICO, and in the five short years since then, ICOs have raised more than \$13 billion, with roughly three projects launching every day in 2018. ICOs have even eclipsed angel investing and venture capital as a primary source of financing for blockchain startups.

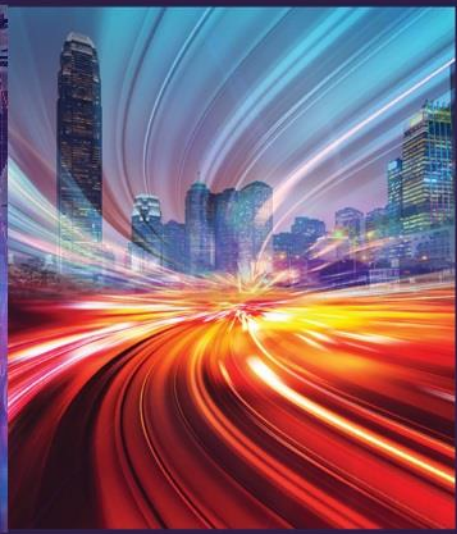
During the early days of the blockchain revolution, running an ICO was both time-consuming and fraught: hackers, bugs, and usability hazards were just a few of the very real and ever-present threats. Worse, there was no consistency on how an ICO was conducted: every startup had its own rules and custom-coded fundraising pages, leading to mass confusion, fraud, and a high likelihood of error. Then, IEOs emerged.



How IEOs works:

With the money we get from our sales, we can list several IEO to exchange per month, which means the use of our packages multiples times a month.

With the exchanges we work with, we get special discounts for listing and speeding up listing.



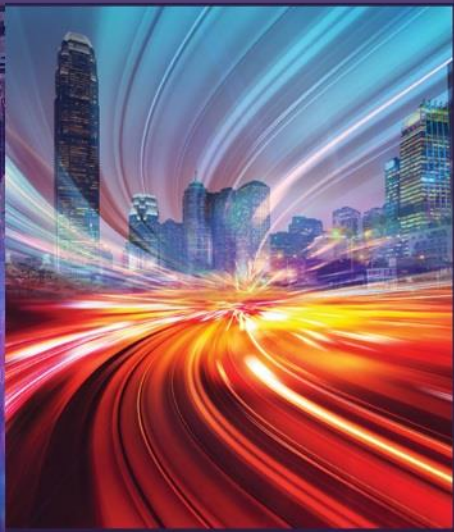

CHALLENGES

There are many currency exchanges that are executed **IEO**, but they are not guaranteed for their success. We understand the value of exchanges and seek to make it easier for you and your investors.

One of the major problems we face is that if the project we are listing for **IEO** fails, our investment will be lost, and another problem is the high cost of listing to many exchanges to execute **IEO**.



SOLUTION

To solve the first problem, we try to make the **IEOs** only in the exchanges that have real volume and user, and the details of each **IEO** will help us to understand the good exchanges more fully.

For second problem, while we try to execute **IEO** in good and real currency exchanges, we try to be careful about their price as well as their power. There are many powerful exchanges have less price list than similar ones and they receive a fine

HOW WE WORK.

We are listed on most of the exchanges held by **IEO** and contracted to do some of their **IEO** listing with a discount. **ICO** who wants to become **IEO** and has no budget chooses one of our packages, we will review them after we have approved the **IEO** teams do their **IEO**

PROFITABILITY (CONTROL PRICE)

We want to look at what is most important to investors (Price)

How are we going to guarantee that our price will not go down and maybe we can say that will our token price large increase?

First of all, we have created our max supply of tokens to be 1 million which is fully controllable by our price maintenance team.

After that every investor know that listing on big money exchanges will increase volume and price and we have to list big exchange because of the nature of our work.

We put a lot of our fund in buy wall support to help investor invest safely.

And since using our packages gives us monthly revenue, we spend our revenue to increase our price and volume so that the early investors, especially private investor, enjoy the joining us.

We will build a six-person team and five of the largest **IEOs** holders will serve on the board of directors and have the right to vote in the company.



PLATFORM

Our platform is erc20 because most exchanges only accept other platform or if they accept other platforms they charge more and since our main job is to list ourselves in most exchanges, so we decided to choose a platform that costs **IEOs** for us.



WHY CHOOSE US?

If you look at a lot of tokens they might have been rising since **ICO** time were profitable for **ICO** buyers, but they weren't usable and didn't do anything special. Enough work, and no longer needing a new **IEO**.

- i. Helping to list good **IEO** to good exchange
- ii. Private investor for ads
- iii. Buy old tokens that were well listed on the exchange and are now price low and become almost inactive. We buy at least 50% of the tokens and list ourselves in another exchange and raise the price



SUMMARY

- i. So, service **IEO** including listing and advertisement etc. without prepayment
- ii. Revive old dead **IEO** (we buy a lot of their tokens and list them I their valid exchanges)

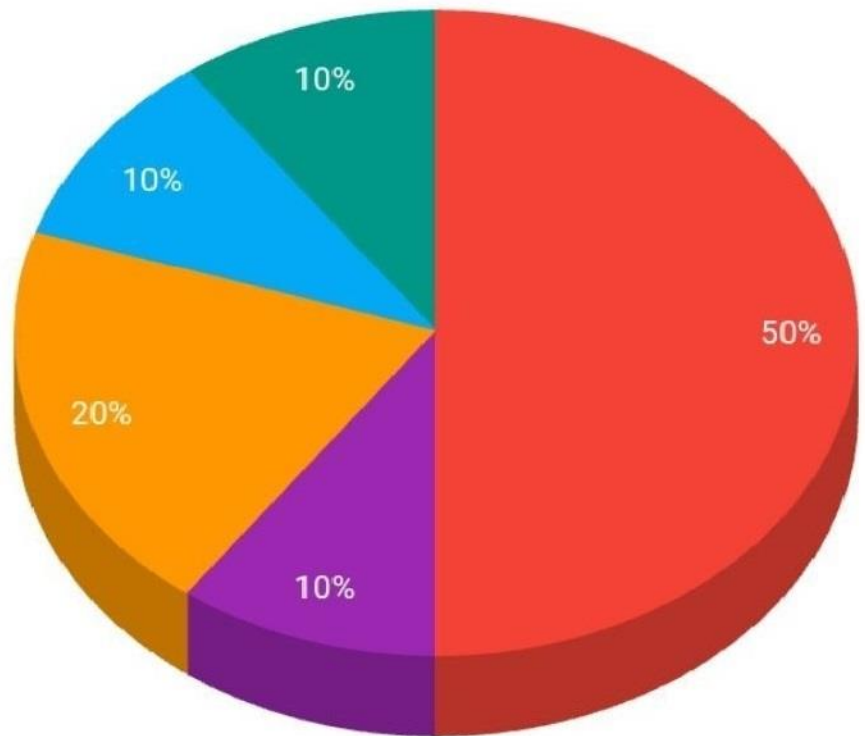

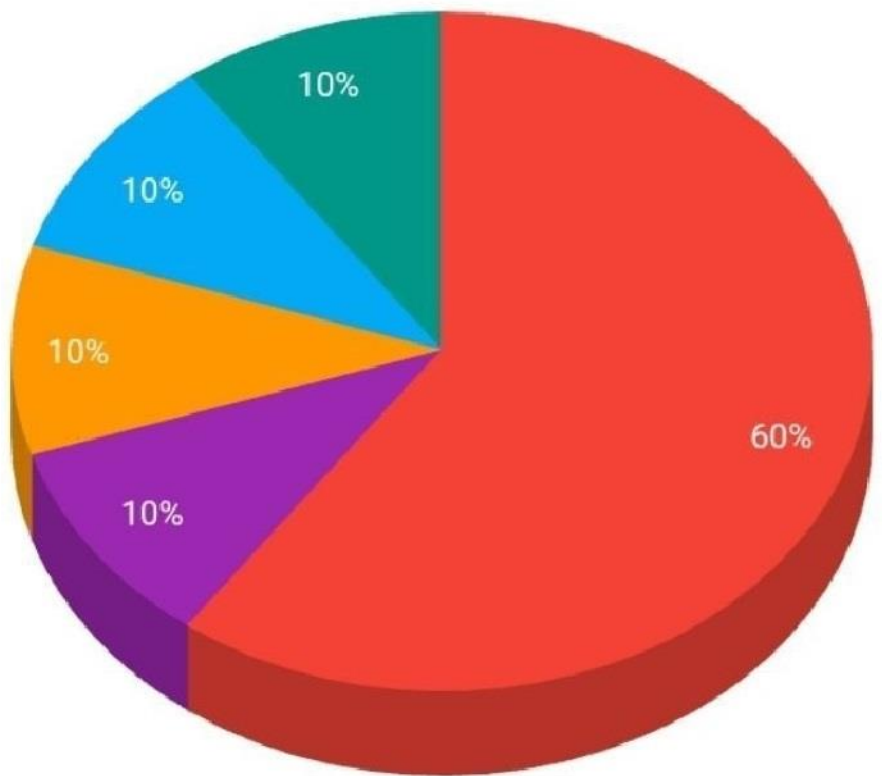
